



Student Agreement

1. Cancellation or Re-scheduling thirty (30) days prior to class start date:

Any Cancellation and /or rescheduling of a curriculum must be received at our K & S Aviation Services', Inc. office thirty days prior to class date by certified mail.

2. Cancellation or Re-scheduling within thirty (30) days prior to class start date:

Cancellation and/ or rescheduling within the 30 days will result in the obligation of payment by student for any simulator and/or aircraft time already scheduled, and the obligation of payment for right seat support for any student left without a partner that cannot be partnered with another student in the same class.

3. Deposit / Refund Policies:

For students enrolled in a training curriculum with **traditional ground school only**: a deposit must be received by K & S Aviation Services, Inc. prior to enrollment in a traditional ground school curriculum. A refund of deposit, minus \$450.00 (which covers received materials and an administrative fee), will be issued for a cancellation greater than thirty (30) days prior to class start date. Training materials are for the student to keep.

For students enrolled in a training curriculum with **online or computer based ground school only**: a deposit must be received by K & S Aviation Services, Inc. prior to enrollment in an online or computer based ground school and is non-refundable. Online or computer based ground school students must complete their online or computer based ground school, K&S review ground school and oral, within ninety (90) days of online or computer based ground school start date. In order to receive an extension, a student will incur an additional fee of \$250.00 Training materials are for the student to keep.

The above required deposits will be valid for twelve (12) months towards the originally scheduled training curriculum. Beyond twelve (12) months, the deposits become non-applicable towards any training.
